In continuation of the notice भर्ती कोषांग (विविध)-03/2019-53 (भ०को०) dated 26-06-2019 regarding list of additional applicants to be called for counseling, applicant-wise explanation for inclusion in the list of applicants to be called for counseling is provided below.

1. Upon receipt of grievance from one of the applicants that whether non-domicile candidate will be considered for benefit of reservation, it was found that there are few applicants whose name have been included in the category list of applicants called for counseling but had not indicated themselves as domicile of Bihar. To maintain 1:2.5 times ratio of applicants called for counseling, without disturbing the applicants already called for counseling, equal number of additional applicants from respective categories in their order of merit have been called for counseling through above mentioned notice. List of such applicants is enclosed with the notice.

2. For the post of Special Survey Assistant Settlement Officer, 50% horizontal reservation has been provisioned in the advertisement published for the position. In the list of applicants called for counseling under WBC category, only 8 such applicants have been called whereas 10 applicants should have been called. Apart from the applicants already called for counseling, only one such WBC applicant is available, who is now being called for counseling. Details of the applicant are as follows:


3. Name of two applicants – Ram Kumar Mahto and Mukesh Kumar Jha were included in the list of additional applicants to be called for counseling. However upon further scrutiny, it was found that the applicants are currently not eligible to be called for counseling. Applicant-wise explanation is as follows:

- a. **Position: SPECIAL SURVEY AMIN, Applicant: Ram Kumar Mahto (JEA/0011352)** – On the basis of details filled in the online application form by the applicant and as per the marking scheme published in the advertisement, revised 'finalpoint' of Ram Kumar Mahto will be 76.45. The applicant was erroneously included in the additional list of applicants to be called for counseling which was published vide notice भर्ती कोषांग (विविध)-03/2019-53 (भ०को०) dated 26-06-2019. Since the revised 'finalpoint' of the applicant which is 76.45 is less than the 'finalpoint' of the last applicant being called for counseling which is 76.52 (as per point 1 above), the applicant is currently not eligible to be called for counseling. The earlier published list stands revised to this extent.
- b. **Position: SPECIAL SURVEY CLERK, Applicant: Mukesh Kumar Jha (LIP/00283153)** – The applicant had submitted grievance that his 'finalpoint' has been wrongly mentioned as 65.87 and correct 'finalpoint' should be 76.72 and in support of his claim has also provided the pdf copy of the application downloaded from the website of the Department of Revenue and Land Reforms. On the basis of applicant's grievance, his name was initially included in the additional list of applicants to be called for counseling which was published vide notice भर्ती कोषांग (विविध)-03/2019-53 (भ०को०) dated 26-06-2019. However upon minute observation, it was observed that print out of the application form submitted by the applicant along with his grievance differs significantly not only on 'finalpoint' but also on several other entries such as Board / University, Passing year, Marks Obtained, Full Marks. In such a situation, 'finalpoint' as mentioned in the pdf copy of the application form submitted by the applicant along with grievance cannot be considered. Therefore the 'finalpoint' of **Mukesh Kumar Jha (LIP/00283153)** will remain 65.87 as published in the List of Applicant who submitted the final application on the website of the Department of Revenue and Land Reforms. The applicant is currently not eligible to be called for counseling. The earlier published list stands revised to this extent.

### Miscellaneous

1. Further to the publication of position-wise and category / sub-category wise Final Point up to which the applicants are being called for counseling (2.5 times of total vacancy), published along with the important notice notification no.- 829 dated: 30/05/2019, it is informed that the Minimum 'final points' up to which, applicants have been called for counseling in Freedom Fighter category of Special Survey Assistant Settlement Officer will be read as **57.00** instead of **57.53**. The list of applicant called for counseling remains the same.

It is to be noted that the applicants have been called for counseling in the ratio of 2.5 times of the vacancies, category-wise for each position. Mere participation in the counseling process does not create any automatic claim or right for selection.
